

IMPORTANT NOTICE REGARDING UPCOMING RATE CHANGES

For the last 50 years, Vermont Gas has maintained competitive and affordable rates for its 50,000+ customers.

We want to let you know about a few upcoming rate changes occurring in February that are impacting the Natural Gas Charge, Energy Efficiency (“EEU”) Charge, as well as the Renewable Natural Gas (“RNG”) Adder. Each of these changes are described below.

First, subject to final regulatory approval, the Natural Gas Charge component of your bill is decreasing by 0.3%, effective with bills rendered on and after February 1, 2019. Vermont Gas adjusts the Natural Gas Charge portion of your bill quarterly, up or down, in response to changes in the cost of gas.

Second, the Vermont Public Utility Commission has approved a reduction in the EEU Charge. The EEU Charge is used to fund the wide range of energy efficiency programs Vermont Gas offers its customers. The EEU Charge will decrease by about 4.8%. We are pleased that we are able to lower the EEU Charge while continuing to offer customers helpful and comprehensive efficiency programs and services. Combined, the net effect of these two changes is an average overall decrease of 0.3% to firm rates.

Pending final regulatory approval of the Natural Gas Charge, the rate components will be adjusted as follows:

Finally, Vermont Gas' Renewable Natural Gas program began in April, 2018 and offers customers the ability to help displace the use of conventional natural gas by purchasing renewable attributes of RNG production. This voluntary program allows customers to sign up for either 10%, 25%, 50%, or 100% of their natural gas usage. The participants in the RNG program are charged an "RNG Adder" corresponding to their chosen percentage on their monthly bills. Vermont Gas will adjust the RNG Adder on a quarterly basis at the same time as the Natural Gas Charge adjustment.

Pending regulatory approval, the RNG Adder will be adjusted as follows:
