

IMPORTANT NOTICE REGARDING RATE CHANGES

For the last 50 years, Vermont Gas has maintained competitive and affordable rates for its 50,000+ customers.

We want to let you know about a few rate changes in effect as of February 1, 2019 that will impact the Natural Gas Charge, Energy Efficiency Utility (“EEU”) Charge, as well as the Renewable Natural Gas (“RNG”) Adder. Each of these changes are described below.

First, per Vermont Public Utility Commission approval, the Natural Gas Charge component of your bill is **decreasing** by 0.3%, effective with bills rendered on and after February 1, 2019. Vermont Gas adjusts the Natural Gas Charge portion of your bill quarterly, up or down, in response to changes in the cost of gas.

Second, the Vermont Public Utility Commission has also approved a reduction in the EEU Charge. The EEU Charge is used to fund the wide range of energy efficiency programs Vermont Gas offers its customers. The EEU Charge will decrease by about 4.8%. We are pleased that we are able to lower the EEU Charge while continuing to offer customers helpful and comprehensive efficiency programs and services.

Combined, the net effect of these two changes is an average overall decrease of 0.3% to firm rates.

The residential rate components are adjusted as follows:

Rate Components	Rates Prior to February 1, 2019	Rates Effective February 1, 2019
Natural Gas Charge (per ccf)	\$0.4188	\$0.4176
Daily Access Charge (per day)	\$0.7260	\$0.7260
Distribution Charge (per ccf)	\$0.6195	\$0.6195
EEU Charge (per ccf)	\$0.0504	\$0.0480
Assistance Program Fee (per month)	\$0.11	\$0.11

Finally, Vermont Gas’ Renewable Natural Gas program began in April, 2018 and offers customers the ability to help displace the use of conventional natural gas by purchasing renewable attributes of RNG production. This voluntary program allows customers to either sign up for either 10%, 25%, 50%, or 100% of their natural gas usage or to allocate a fixed amount of RNG attributes per month. The participants in the RNG program are charged an “RNG Adder” corresponding to their chosen percentage or fixed amount on their monthly bills. Vermont Gas will adjust the RNG Adder on a quarterly basis at the same time as the Natural Gas Charge adjustment.

The RNG Adder are adjusted as follows:

RNG Adder	\$1.2914	\$1.2931
