### Rebate Program Terms & Conditions

1. You must be a **commercial** customer of Vermont Gas with a G1, G2, G3 or G4 natural gas rate and installing high efficiency gas equipment in an existing building. If your project is new construction or you are a new Vermont Gas customer, please contact Vermont Gas (802) 951-0389 for assistance.
2. Your total rebate must be equal to \$4,000 or less. If your rebate amount exceeds \$4,000 you must contact Vermont Gas prior to doing the work and prior approval and incentive agreement will be required.
3. Equipment must be purchased and installed between January 1, 2020 and December 31, 2020 in order to qualify. Rebate forms must be received at Vermont Gas or postmarked by January 31, 2021.

If Customer is not the owner of the Property, Customer has received authorization from the owner of the Property.
