* The AFUE (Annual Fuel Utilization Efficiency) of proposed new equipment can be found at www.ahridirectory.org or www.energystar.gov/products. The EF (Efficiency Factor) for water heaters is based on the amount of hot water produced per unit of fuel consumed over a typical day. A higher AFUE or EF indicates more efficient equipment.

- 2. Complete the rebate application and include the contractor's final invoice. An application may be submitted online at vermontgas.com**
- 3. Once 1 & 2 have been completed, we will issue a rebate check directly to the homeowner.**
