

## IMPORTANT NOTICE REGARDING UPCOMING RATE CHANGES

---

For over 50 years, VGS has maintained competitive and affordable rates for its 54,000+ customers. As we work to enhance our customer service and make investments in safety and Vermont's clean energy future, we are committed to keeping those rates low for current and future customers.

We want to let you know about two rate changes pending regulatory approval. The first one will go into effect in August and impacts only the Natural Gas Charge. The second one expected in November will impact each rate component. Each of these changes is described below.

First, the Natural Gas Charge component of your bill is increasing by 4.4% effective with bills rendered on and after August 6, 2021. VGS adjusts the Natural Gas Charge portion of your bill quarterly, up or down, in response to changes in the cost of gas. The other components of your bill will not change at that time.

The effect of this change on your bill will vary depending on your natural gas usage but, on average, is equivalent to an overall increase of 1.4%.

Next, on February 16, 2021, VGS filed a request with the Vermont Public Utility Commission to change the Daily Access and Distribution Charges as well as the Natural Gas Charge. The effective date of this proposed change is dependent on the regulatory review process but is anticipated to go into effect in November 2021. The rate request is an overall rate increase of 2.6% from the rates in effect as of February 2021.

The overall rate change is comprised of a 4.1% increase in the Natural Gas Charge portion of your bill and a 1.95% increase in the Daily Access and Distribution Charges. To limit the increase in the Daily Access and Distribution Charges to 1.95%, VGS has also requested that the Commission allow us to return to customers approximately \$4.44 million of the System Expansion and Reliability Fund ("SERF") that the Commission authorized in 2011 for future use to help bring natural gas service to more Vermonters.

Please note that the increase in the Natural Gas Charge portion of the bill is based on rates in effect as of February 16, 2021. The actual percent change will depend on natural gas costs at the time of the November 2021 rate change and, under our current regulatory framework, the Natural Gas Charge will continue to change quarterly until then.

Pending regulatory approval, the rate components will be adjusted as follows:
